A survey has been developed for the community to select their two (2) preferred options for the location of two (2) disabled parking spaces in Dandaloo Street, Trangie. The community is asked to rank the four proposed locations in priority from 1 (most preferred) to 4 (least preferred).

**PUBLIC EXHIBITION – ROAD NAMES AT NARROMINE AVIATION BUSINESS PARK**

Council resolved at its monthly meeting held on 8 July 2020 to approve the following street names for the new Narromine Aviation Business Park development at Narromine Aerodrome, Mitchell Highway, Narromine.

The three preferred names for roads 1, 2 and 3 respectively are; Powell, Hayden and Pay. If any of these names should not be suitable, or other names are required at a later time at the Aerodrome Precinct the alternatives to be considered are Johnston, Coomber and Butler. Please note that following the public exhibition period, Council will select the road type (i.e. Street, Alley etc) to ensure it complies with the criteria under AS/NZS 4819:2011.
