LEVEL 3 WATER RESTRICTIONS REMAIN IN PLACE

Level 3 water restrictions remain in place in Narromine town at this time. Thank you to all residents for water saving efforts to date which has seen an overall drop in water usage by about 10%. Despite the cooler weather, lower water levels in supply aquifers mean that restrictions will remain in place at this time and will be evaluated month by month.
