Narromine Shire Council has been invited by the Murray Darling Association (MDA) to nominate for Chair of Region 10. Councils of Region 10 include Bathurst Regional, Bourke Shire, Dubbo Regional, City of Lithgow, Oberon, Upper Hunter Shire, Bland Shire, Cabonne, Forbes Shire, Mid-Western Regional, Orange City, Upper Lachlan Shire, Blayney Shire, Cobar Shire, Goulburn Mulwarra, Muswellbrook Shire, Parkes Shire, Warren Shire, Bogan Shire, Cowra Shire, Lachlan Shire, Singleton, Warrumbungle and Narromine Shire.

Regional meetings are held quarterly in various locations in the region. The meetings provide an opportunity for Councils to access and contribute important information on the management of the Murray-Darling Basin resources, and elevate issues affecting local communities.

Chairing Councils work with the MDA executive to determine the agenda, dates and locations of region meetings.
