The format of the motions, as much as possible, should call on a specific body (e.g. LGNSW, State Government, Federal Government etc) and have a specific outcome that the motion is aiming to achieve. The wording should be unambiguous.

Motions must be supported by Council, i.e. extract from minutes of the Council Meeting, or in the absence of a Council Meeting, the evidence should be a letter signed by both Mayor and General Manager.
