- Oval surface is in need of inspection and pool house area needs to be rehabilitated.

Main Purpose of the meeting

Monthly Meeting

Key Messages/Highlights

- Regretful resignation of Jodi Browning from the Narromine Health Council. The committee elected new member (Dr) Robert Kirkby as Chair.
- The Chair welcomed the recently appointed Health Manager, Ms Julie Kirk. Ms Kirk plans to live in Narromine and become part of the community.
- The new committee decided to 'start from scratch' and to commence a membership drive.
- There was a discussion on the availability of hospital beds, with the number capped at 12. Extended stay patients won't be encouraged as the Health Service Manager stated that the hospital is an acute facility and patients from Narromine are the hospital's priority.
- Transitional care is Federally funded.
- Patients for rehab will find a bed.
- Discussion on health care for patients who are not well enough go home but not ready to go to Timbreebongie. To be discussed at a further meeting.
- Discussion on the reasons why it is difficult to get doctors to come out to country areas.
- Hospital staff is to triage patents before sending to the Narromine Shire Medical Centre .
- The committee formed the following vision statement: To have doctors living in Narromine who attend the hospital and become part of the community and do their best by the community.

That Council is supportive of any moves by the Narromine Health Council to assist in attracting young doctors and their families to not only practice in Narromine but also live in Narromine.
