5. ORANA JOINT ORGANISATION OF COUNCILS

Joint Organisations of Councils were formally instituted through changes to the Local Government Act in 2017. Previously Council had been a member of the Orana Region of Councils (OROC) which operated without excessive membership fees and regulatory responsibilities.

The requirements for the operation of Joint Organisations are similar to that of Councils, particularly in relation to financial management and auditing, as well as the formation of Internal Audit, Risk and Improvement Committees. These regulatory burdens require significant financial expenditure. The decision by Dubbo Regional Council to not join the Orana Joint Organisation meant that any financial burdens fell to the other member Councils.

Despite ongoing representations to the State Government, no appropriate funding model has been presented that is workable for the member Councils of the Orana JO. In the absence of funding, and not wanting to burden each Council's ratepayer base with significant fee increases, the Orana JO has been operating with the General Manager of Mid-Western Regional Council acting as the Executive Officer in a voluntary capacity.

The decision has been now reached by the Orana JO that is it is time for each Council to consider its position in the JO.

5. ORANA JOINT ORGANISATION OF COUNCILS (Cont'd)

In order to dissolve the Orana JO, each member Council must first obtain a resolution to resign and then a request will be put to the Local Government Minister to dissolve the Orana JO in accordance with Section 400ZC of the Local Government Act. This report now seeks to move forward with the process of formally disbanding the Orana Joint Organisation.

It is noted that the risk of withdrawing from the Orana Joint Organisation will be viewed negatively by the State Government and could impact current and future funding agreements. It is also noted that without substantial financial input by member Councils, or Dubbo Regional Council becoming a member in the near future, the Orana Joint Organisation is at risk of becoming insolvent.

RECOMMENDATION

That Council: -

- 1. Note the ongoing concerns about the financial sustainability of the Orana Joint Organisation;
- 2. Resign its membership of the Orana Joint Organisation;
- 3. Make the relevant representations to the Orana Joint Organisation seeking agreement from all member Councils on this issue;
- 4. Work with the Orana Joint Organisation to write to the Minister for Local Government seeking the relevant legislation be enacted to dissolve the Orana Joint Organisation.
