**4) TRAFFIC FACILITIES FOR THE PROPOSED TOMINGLEY SERVICE STATION LOCATED  
ON LOT 10 -12 MERILBA STREET, TOMINGLEY**

Discussion was had regarding the provisional comments, drawings, the DA and signage.

The General Manager invited the Manager of Planning in to discuss the application.

Emma Yule, Manager Planning, NSC entered the meeting at 9:57am

The Manager Planning noted the conditions of consent were to design it for a 35m articulate vehicle.

André Pretorius, Director Infrastructure & Engineering Services, NSC entered the meeting at 10:03am.

The Director Infrastructure & Engineering Services noted the desired outcome was to keep the truck/carpark in its current form and to stop large trucks entering Gennangie Street. Rear access would still be available to the truck parking areas for vehicles under 12.5m.

David Vant noted, allowing two way and limited access on the one road way would be an issue with signage, and would solve everything if the back access to the truck/carpark entry to the service station was a two-way road.

Further discussion was had regarding the current drawings and road directions.

**5) TRANGIE LEVEL CROSSING – Cnr of Mitchell Highway and Saleyards Road

Discussion was had regarding road length, turning lanes, B-double and road train routes, access from Saleyards Road and Prohibition Signs. Also, consider options for the Truck Stop to be included, subject to a separate report.

David Vant noted this intersection did not arise when the last short stacking issues were investigated in this area.

David Vant noted he would investigate prohibition signage. The RMS are responsible for highway signage, with the Council responsible for signage on local roads.

**7. GENERAL BUSINESS**

**a) Noise complaint Warren Road**

The Director Infrastructure & Engineering Services noted Council has received further complaints from effected residents regarding trucks parking along the Narromine Golf Club. The Director Infrastructure & Engineering also noted he had contacted the Narromine Golf Club and they have concerns of employees leaving their premises late at night. Perhaps a restricted hours parking zone could be implemented.

Cr McCutcheon would like it noted that Council investigate options of additional truck stops into the future.

Andrew Pearce noted that rule 200 in the road rules states long vehicles can not stop for longer than 1 hour in a residential area, but, section 281 states fatigue management allows them to stop.

The Chair suggested replying to the resident advising them that Council will investigate the option of designing signage encouraging drivers to use the truck stop with shower and toilet facilities near the Narromine Saleyards.

**RECOMMENDED** David Vant/Cr McCutcheon that Council investigate the design of signage encouraging drivers to use the truck stop with shower and toilet facilities near the Narromine Saleyards.

**b) Heavy Vehicle complaint Tomingley**

The Sub Branch has requested the closure of:

- Dandaloo Street from Meringo Street/Second Avenue through to Derribong Street/Avenue;
- Burroway Street from Merilba Street to Dandaloo Street.

Whilst troops will fall in at 10:00am in front of the USMC and the March will be finalised by approximately 12pm, the requested period of closure is from 9:00am until 12:30pm - 1:00pm to allow for setting up / packing up time and removal of road closure barricades.

The Sub Branch has submitted a completed RMS "Traffic and Transport Management of Special Events" form together with a Traffic Control Plan, Risk Assessment and Management Plan, and a copy of their current Public Liability Insurance Policy.

#### **Executive Summary**

The purpose of this report is to provide the Local Traffic Committee with information regarding a proposed road closure, not involving road works on 24 May 2020.

---

#### **Report**

Council has received a request from Royal Far West to hold a criterium race in Narromine on 2 May as part of their Ride For Country Kids 2021. The event will require the temporary closure of a number of streets for approximately 1 hour.

A completed Application for Road Closures for Special Events form has been received by Council (**provided to the committee under separate cover**), and the Road Occupancy Licence application has been submitted to the RMS. The following documents will be supplied to Local Traffic Committee members at the April Meeting;

- Risk Assessment
- Event Management Plan
- COVID Management Plan

There will be approximately 80 riders taking part in the Ride For Country Kids event from Dubbo to Cobar from 2 to 4 May 2021. Royal Far West Children have requested the ability to run a short cycle criterium around Meringo Street, Dandaloo Street, Nymagee Street and Meryula Street. The race will be sanctioned by Royal Far West, supported by Entoure – Cycle Event Management and run for approximately 1 hour. The ride will give the community a great opportunity to take part in this fundraising initiative. It is likely that the street would need to be closed temporarily for this time.

#### **RECOMMENDATION**

**Executive Summary**

The purpose of this report is to obtain comment and endorsement on the attached design drawings for traffic facilities "Lines and Signage" for the proposed service station in Tomingley.

---

**Report**

As part of the Development Application and relevant approval processes, the proponent has submitted design drawings (**provided to the committee under separate cover**), pertaining to traffic facilities (lines and signage) for consideration and endorsement by the Local Traffic Committee. These drawings were previously distributed to Transport for NSW (TfNSW) for comment and approval. However, TfNSW indicated that this matter should be discussed at the Local Traffic Committee meeting. Concerns have been raised regarding traffic movements especially from heavy vehicles entering the Tomingley Truck Stop from the rear of Genanagie Street. Therefore, it is suggested that an additional supplementary plate (r9-223) is installed below the "No- entry Signs". Please refer to the example below:



This will allow vehicles such as a garbage truck or other service vehicles less than 12.5m in length to enter Genanagie Street from this location.

While the complete drawing package has been provided to the Committee (under separate cover) to explain the context of the development and traffic movements, endorsement is sought particularly for the following drawings:

The purpose of this report is to provide the Local Traffic Committee with information regarding a near hit at the Railway crossing and proposed treatment options at the Western Rail Level Crossing.

---

Council has received a report of a near hit with a train at the Western Rail Level Crossing linking Trangie Saleyards Road to the Mitchell Highway, **(provided to the committee under separate cover)**.

On 4 March 2021, Council representatives met with John Holland representatives to discuss the near hit and possible treatment options **(provided to the committee under separate cover)**.

Council further received correspondence regarding safety concerns of heavy vehicle movements at the Trangie Silos, located on Saleyards Road **(provided to the committee under separate cover)**, on 17 March 2021. Council approached John Holland Group (JHG) for comment regarding railway safety related matters. Unfortunately, no comment has been provided by JHG by prior issuing this report.

**RECOMMENDATION**

1. That this report be accepted by the Committee;
2. That Council re-measure the distance from the level crossing and the hold line with the Mitchell Highway and confirm the correct vehicle length that can safely stop between the level crossing and the Mitchell Highway.
3. That, if required, NSC confirm vehicle lengths with the NHVR and TfNSW.
4. That Council discuss with TfNSW the possibility of the provision of slip lane for vehicles turning left off Mitchell Highway (to avoid long vehicles blocking a traffic lane).
5. NSC to advise TfNSW of missing 'Level Crossing on side road' signage on Mitchell Hwy.
6. NSC to provide gating of level crossing signs on Sahara Road (both approaches).
7. NSC to engage with Dubbo Police LAC to provide random patrolling of this site.
8. NSC to refresh road line markings.
9. That the request to add an advisory "Trucks Exempted" plate below the "Stop" signs be considered once rail safety advice from JHG is obtained.
10. That the proposed works be undertaken and in consultation with relevant stakeholders.
