Executive Summary

This report provides information to Council in regard to the suggested sale price and lease price for the hangars under construction at the Aviation Business Park.

Report

In August 2020 funding was confirmed from the Murray Darling Basin Economic Development Program to enable the development of hangars at the Aviation Business Park to assist in attracting aviation related businesses.

Since then Council staff have been working to undertake this development and while the works have taken much longer than expected the work is nearing completion, now expected in January 2023.


Two hangars have now been built, both to the same specification on lot 3 and lot 19 in the Business Park

Works include:

- Main shed 20m by 20m approx. 6m high to roof edge
- 40m2 staff area/ staff amenities
- 3 phase electrical and power throughout
- NBN
- Access to taxiway with bitumen sealed hardstand
- Staff car park
- Sewer and Water connection
- Land size 2250m2
