RESPONSIBLE PET OWNERSHIP and REGISTRATION

Pet owners are reminded to **microchip and register** their dog or cat and ensure that their contact details are up to date and to ensure the animal can be returned to its owner if it is found or impounded.

Any person wishing to register a cat or dog can do so at Council's Customer Service and Payments Centre at 120 Dandaloo Street, Narromine.

Lifetime registration is required by the time the animal is 6 months of age and takes place after your dog or cat is microchipped. Registration can be paid at any council, completed online at www.petregistry.com.au at any Service NSW branch or through a MyService NSW account at www.service.nsw.gov.au.
