## Purpose of this application form:

Holder/s of a perpetual right that has been revoked by a cemetery operator can use this application form to seek compensation. The former holder is entitled to:

- a perpetual interment right granted for an alternative interment site in the same cemetery, or
- compensation paid by the cemetery operator of an amount equal to half of the fee payable for the granting of a perpetual interment right for an alternative interment site in the same cemetery (see section 52 of the Cemeteries and Crematoria Act 2013).
